

ELECTION ANNOUNCEMENT

**for the Election of the Dean of the Faculty of
Computer Science
European Campus Rottal-Inn**

of the Deggendorf Institute of Technology on June 28 and 29, 2022

According to Art. 33 Para. 1 of the Basic Regulations of the Deggendorf Institute of Technology, the election of the Dean of the Faculty

**Computer Science
European Campus Rottal-Inn**

takes place at the same time as the university elections. All members of the respective faculties are entitled to vote.

The tenure of office of the elected Dean begins on October 01, 2022 and ends on September 30, 2025.

The exercise of the right to vote depends on the entry in the electoral roll. The electoral roll is available at

and can be viewed from **May 26 to 31, 2022 from 8 a.m. to 4 p.m (Fridays until 12 a.m.)**. Those concerned may submit written objections to non-entry or incorrect entry in the electoral roll to the returning officer by **June 01, 2022, 4 p.m.** at the latest.

Those entitled to vote shall be invited, during the period from

April 27 to May 10, 2022

to submit election proposals to the election officer. Nominations must be made in writing. Samples for election proposals are available at **wahlen@th-deg.de** and on the **website of the Deggendorf Institute of Technology** (<https://www.th-deg.de/en/students/campus-life#elections>).

A nomination for election as Dean must be signed by at least five persons who are entitled to vote for the respective faculty.

When signing the nomination, proposers must state their surname and first name, office- and job title, job position as well as the faculty to which they belong. Insofar as to identify the proposer, date of birth must be given. A person entitled to vote may support only **one nomination** for election as Dean; if someone has signed several nominations, the

signatures on all nominations are invalid. Nominations that are submitted belatedly are invalid. Only persons who have been included in a valid nomination can be elected.

The candidate's written declaration of consent to the candidacy for this nomination must be submitted with the nomination. A candidate may only be named on one nomination.

Approved nominations will be announced by June 14, 2022 at the latest at the Deggendorf Institute of Technology designated for official announcements and on the website of the Deggendorf Institute of Technology (<https://www.th-deg.de/en/students/campus-life#elections>).

Voting will take place on


**June 28 and 29, 2022 from 9 a.m. to 2 p.m.
in Deggendorf and Pfarrkirchen**

The exact **place of voting** shall be notified in an electoral notification. The persons entitled to vote shall receive the voting notifications by e-mail before the date on which the electoral roll is closed.

Voting is also permitted in the form of postal voting. Those entitled to vote who intend to cast their vote in the form of a postal vote must apply to the returning officer for the election documents to be sent or handed out in writing (e.g. with the form posted on the internet or per E-mail to wahlen@th-deg.de). The application must be received by the returning officer by **4 p.m. on June 14, 2022** at the latest. If you receive the postal vote documents in person, you can apply for a postal vote until **June 21, 2022, 4 p.m.** in the Deggendorf Institute of Technology, Room ITC2 2.56, Dieter-Görlitz-Platz 2, 94469 Deggendorf.
